UKRAINE IN HORIZON 2020



On 20 March 2015, Carlos Moedas, European Commissioner for Research, Science and Innovation and

Serhiy Kvit, Minister of Education and Science of Ukraine, signed the Horizon 2020 Association Agreement.



On 27 June 2016 Ukraine joined the Euratom Research and Training Programme
The agreement was signed in Brussels by Carlos Moedas, European Commissioner for Research, Science and Innovation, and Pavlo Klimkin, Minister of Foreign Affairs of Ukraine. The signing was in the presence of Petro Poroshenko, President of Ukraine.



Action Plan of Ukraine on participation in Horizon 2020

- 1. Establishment of a joint commission on the program implementation coordination with the participation of responsible central executive authorities, NASU, etc.
- 2. Establishment of a structural unit responsible for Horizon 2020 implementation
- 3. Functioning of Program Committees Delegates; selection of the delegates
- 4. NCP activities' support
- 8. Development of a Horizon 2020 National Portal (<u>www.h2020.com.ua</u>)
- 9. Raising awareness of society on Horizon 2020 programs and activities (Promotion, Information Campaign on the permanent basis)
- 10. Peer review of National science and innovation system
- Adjustments of the national legal framework to European standards, improvement of R&D legislation (taxes, obligatory currency exchange, etc.)
- Development of Science & Business partnerships
- 13. Involving Ukrainian scientific diaspora in Ukrainian R&D activities

By the order of the MESU as of 13 March 2015 the Ukrainian NCPs Network was established on the base of the Universities and Academic institutions of Ukraine.


By the order of the MESU as of 2 September 2016 the Ukrainian NCPs Network was updated.

Horizon 2020 First Results 2014-2016 After First 274 Calls

61 projects with **79** participants from Ukraine were supported for funding and **11 536 412** Euro Budget were allocated to Ukraine

Success rate ~10,0%



Ukraine establishes H2020 coordination centre

A related resolution was adopted at November 30 at the meeting of the Cabinet of Ministers of Ukraine.


The Coordination Centre works on more effective solutions to the problems that arise during the implementation of projects funded under H2020 in Ukraine.

The adopted resolution also comprises the establishment of a selection commission to choose the representatives and experts for the programme committees of the Framework Programme Horizon 2020.

The main tasks of the Coordination Centre are to provide fast and efficient solutions on the issues that occur during implementing H2020 projects and to facilitate considerations of Ukrainian participants' interests in the programme. In future it shall become a platform for developing an agreed position and to bundle the central state bodies' activities in regard to the implementation of Horizon 2020 in Ukraine.
